THE CHAIR

A substitute ordinance relating to traffic controls in various Aldermanic Districts.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-12-2 of the Code relating to No U Turns is amended by adding the following:

In the median opening on West Michigan Street between North 8th Street and North 9th Street westbound

Part 2. Section 101-13-8 of the Code relating to School Speed 20 MPH is amended by adding the following:

On West Center Street from North 14th Street to North 17th Street

On West Capitol Drive from North 11th Street to North 13th Street

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

"On North Hubbard Street at East Reservoir Avenue"

Part 4. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On North 67th Street at West Ruby Avenue

On West Pierce Street and South Shea Avenue in all directions

Part 5. Section 101-16-2 of the Code relating to Thru Highways is amended by striking the following:

"East/West Brown Street from the west line of North Holton Street to the east line of North 3rd Street"

Part 6. Section 101-22-1 of the Code relating to One-Way Streets is amended by adding the following:

On West Leroy Avenue from a point 150 feet west of South 51st Street to South 55th Street westbound Department of Public Works Infrastructure Services JHS:dle 12/16/03
