Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes

the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

S. 23rd St. - W. Maple St. to W. Mitchell St. (ST211040115) File Number 021622: Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, grading, and tree removal where necessary. (Assessable Reconstruction Paving Fund -- \$9,400; Nonassessable Reconstruction Paving Fund -- \$41,300)

11th Aldermanic District

S. 68th St. - W. Howard Av. to S. Honey Creek Dr. (Service Drive) (ST211040110) File Number 020915: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$32,000; Nonassessable Reconstruction Paving Fund -- \$16,600)

S. 39th St. - W. National Av. to W. Pierce St. (Portions in the City of West Milwaukee) (ST211030116) File Number 891874: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$40,200; Nonassessable Reconstruction Paving Fund -- \$48,900; (Developer Paving Fund (ST214040101) -- \$75,000)

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which

are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects: S. 23rd St. (ST211040115), S. 68th St. (ST211040110), and S. 39th St. (ST211030116) will be billed after January 1, 2006, but not before 12 months after the project contract has been completed; and, be it

**Further Resolved, That the following project be deleted from the 2004 Paving Program.**
