Whereas, The claimant, Victor Beecher, through his attorney, Robert A. Levine, has filed a claim for damages against the City of Milwaukee pursuant to Wis. Stat. § 66.189, for injuries and damages incurred on October 6, 2002, as a result of a vehicle accident with an uninsured motorist; and

Whereas, The claimant has agreed to settle his claim in the amount of \$9,000.00; and

Whereas, Pursuant to Common Council Resolution File No. 890916, the City Attorney's Office retained the services of the law firm of Crivello, Carlson & Mentkowski, S.C., to administer the City of Milwaukee's uninsured motorist self-insurance plan; and

Whereas, The law firm of Crivello, Carlson & Mentkowski, S.C., recommends and the Common Council of the City of Milwaukee deems it expeditious and just to settle this claim; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper city officers be and hereby are authorized and directed to issue a check in the amount of \$9,000.00, payable to Victor Beecher and Attorney Robert A. Levine-Trust Account, in full and final settlement of said claim, said
