Part 3. Section 1 of ordinance File Number 030415 relative to offices and positions in the City Service is hereby amended as follows:

Under "Employes' Retirement System, Membership Services", delete one position of "Program Assistant II" and add one position of "Administrative Services Specialist."

Part 4. Section 1 of ordinance File Number 030415 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department, Home Environmental Health Division, Lead Urban Initiatives Grant (LL)", delete one position of "Program Assistant I(LL)" and add one position of "Program Assistant II(LL)."

Part 5. Section 1 of ordinance File Number 030415 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 9, 2004 - April 20, 2004):

Under "Mayor, Administration", delete one position of "Staff Assistant to the Mayor-Senior" and add one position of "Staff Assistant to the Mayor."

Part 6. Section 1 of ordinance File Number 030415 relative to offices and positions in the City Service is hereby amended as follows:

Under "Department of Public Works-Water Works, Business Organization, Auxiliary Positions", delete one position of "Water Revenue Manager" and add one position of "Project Manager."

Part 7. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 8. The provisions of Part 5 of this ordinance are deemed to have been in force and effect from and after Pay Period 9, 2004 (April 20, 2004).

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 9. This ordinance will take effect and be in force from and after its passage and publication.
