## THE CHAIR

Substitute ordinance relating to the change in zoning from Park (PK) to Single-Family Residential (RS4) on land located on the West Side of North 46th Street and North of West Green Tree Road, in the 1st Aldermanic District.

This substitute ordinance will allow for the relocation or construction of single-family dwellings.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-501.1(b).0002. The zoning map is amended to change the zoning for the area bounded by the zoning line within the right-of-way along vacated West Hustis Street, the zoning line within the right-of-way along North 46th Street, the zoning line within the right-of-way of West Green Tree Road, a line 120 feet West and parallel to the west line
