THE CHAIR Ordinance relating to the change in zoning from Two-Family Residential (RT4) to Local Business (LB2) on land located on the West Side of South 4th Street and North of West National Avenue, in the 12th Aldermanic District. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-601.2.0010. The zoning map is amended to change the zoning for the area
