This resolution requires the cancellation of taxes because of a decrease in assessment as made by the Wisconsin Tax Appeals Commission of the Wisconsin Department of Revenue of Tax Key No. 463-9995-200-X for 2003, the issuance of checks to the City Treasurer or taxpayer as applicable, and the proper reductions of State Tax Credits by journal entries.

Whereas, An assessment in the amount of \$920,300 (Land: \$920,200 - Improvements: \$100) was made against the real estate property known as Tax Key Number 463-9995-200-X, for the year 2003; and

Whereas, The Wisconsin State Board of Assessors of the Wisconsin Department of Revenue has decreased this assessment to \$315,500 (Land: \$315,400 - Improvements: \$100), for a reduction of \$604,800; now, therefore, be it
