THE CHAIR

Resolution authorizing the Milwaukee Police Department to accept and expend Regional Training Center payments from other law enforcement jurisdictions and to use these funds for equipment needed for the Regional Training Center. (Police Department)

Whereas, The Common Council passed File Number 930380 on July 6, 1993, an ordinance codifying the City's procedural guidelines regarding the receipt, appropriation, and expenditure of contributions; and

Whereas, The Milwaukee Police Department has been designated as a Regional Training Center by the State of Wisconsin Law Enforcement Standards Board, and receives payment from other law enforcement jurisdictions for training received at our Training Academy; and

Whereas, The Milwaukee Police Department anticipates continued receipt of these payments for the "Regional Training Center"; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Police Department is authorized to accept and expend funds up to \$100,000 for the purpose of establishing a "Regional Training

Center Account” in accordance with established City policies and procedures for acceptance of contributions; and, be it

Further Resolved, That upon receipt and deposit of these funds, the City Comptroller is authorized and directed to establish a Special Account within the Police Department's budget for the expenditure of this contribution; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer appropriations and estimated revenue from the Contribution Fund-General, Account number 0001-2110-0001-D001-006300, and the estimated revenue account for Contributions, Account Number 0001-2110-0001-009850 to the Police Department's special account 0001-3310-0001-Dxxx-006800, 0001-3310-0001-Dxxx-006300, and the Police Department's estimated revenue account 0001-3310-0001-009850 up to the amount of \$100,000.00; and, be it

Further Resolved, That such authority to accept contributions for said purpose shall continue unless otherwise rescinded or amended by future Common Council action.
