Resolution approving, ratifying and confirming a memorandum of understanding between the City of Milwaukee and Milwaukee District Council 48, AFSCME, AFL-CIO relative to providing the Health Department with the ability to compensate certain employees for overtime worked in cash instead of compensatory time off.

The purpose of this resolution is to confer Common Council approval, ratification and confirmation on a memorandum of understanding between the City of Milwaukee negotiating team and Milwaukee District Council 48, AFSCME, AFL-CIO relative to providing the Health Department with the ability to compensate certain employees for overtime worked in cash for the time period beginning July 4, 2004 and ending September 25, 2004.

Whereas, Agreement between the City of Milwaukee negotiating team and Milwaukee District Council 48, AFSCME, AFL-CIO has been reduced to writing; and

Whereas, The memorandum of understanding embodying this agreement, copies of which are attached to Common Council File No. 040423 and incorporated herein as though fully set forth at length, was executed subject to ratification by the common council; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the agreement between the City of Milwaukee and

Milwaukee District Council 48, AFSCME, AFL-CIO be approved; and, be it

Further Resolved, That the proper city officials are hereby authorized and directed to take the necessary action or to make the necessary recommendations to the Common Council or the appropriate committees or boards to implement the terms of this agreement; and, be it

Further Resolved, That such sums as are necessary for the implementation of the aforementioned memorandum in accordance with its terms and conditions be obtained for and charged to the appropriate departmental budget accounts in accordance with the customary reporting and accounting requirements.
