A substitute resolution authorizing settlement of the lawsuit regarding Options for Community Growth, Inc., et al. v. City of Milwaukee, Case No. 03-C-1275

This resolution authorizes payment of the settlement amount of \$194,000 to complete settlement of the lawsuit of Options for Community Growth, Inc., et al. against the City of Milwaukee.

Whereas, the plaintiffs, Options for Community Growth, Inc., Humboldt House, LLC, Larry Butler and REM Wisconsin II, Inc. have filed a lawsuit against the City of Milwaukee seeking an unspecified amount of damages and attorney's fees; and

Whereas, the plaintiffs have agreed to settle the lawsuit in the amount of \$194,000, in addition to an agreement to amend certain city ordinances relating to the distance regulation of community living arrangements, a legislative act that has already been adopted by the City of Milwaukee; and

Whereas, the City Attorney recommends and the Common Council of the City of Milwaukee deems it is expeditious and just to pay this lawsuit; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper city officers be and are hereby authorized and directed to issue a city check in the amount of \$194,000, payable to the order of the Trust Account of Robert Theine Pledl, in full and final settlement of said claim, upon receipt of a Release Of Claims, Approved as to form and execution by the City Attorney, City of Milwaukee charged to Account No. 006300.
