THE CHAIR

Resolution authorizing a sidewalk replacement project in the Eighth Aldermanic District.

To provide the necessary authority for sidewalk repairs in the Eighth Aldermanic District.

Whereas, It is necessary and in the public interest to replace those sidewalk stones which are cracked, broken, out of grade or otherwise a hazard to pedestrians; and

Whereas, It is proposed that sidewalk replacement work be done in the following locations at the indicated cost:

Area bounded by West Greenfield Avenue, South 35th Street, West Burnham Street and West City Limits in the Eighth Aldermanic District ST230060128.

; and

Whereas, Funds have been encumbered and thus set aside for the proposed public improvement; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works be, and is hereby authorized and directed to proceed to do the above described sidewalk replacement work and the City Comptroller is hereby authorized and directed to transfer \$22,500.00 from Account No. 0333-4926-ST230060000 and \$222,500.00 from Account No. 0330-4926 ST230060000 which is available for sub-

accounts; and, be it
