Whereas, It is necessary and in the public interest to replace those sidewalk stones which are cracked, broken, out of grade or otherwise a hazard to pedestrians; and

Whereas, It is proposed that sidewalk replacement work be done in the following locations at the indicated cost:

Area bounded by West Bradley Road, North 107th Street, West Brown Deer Road and North 91st Street in the Ninth Aldermanic Districts, ST230060127.

Whereas, Funds have been encumbered and thus set aside for the proposed public improvement; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works be, and is hereby authorized and directed to proceed to do the above described sidewalk replacement work and the City Comptroller is hereby authorized and directed to transfer \$60,000.00 from Account No. 0333-4926-ST230060000 and \$140,000.00 from Account No. 0330-4926, ST230060000, which is available for sub-
