Substitute resolution relating to the appeal of Ingrid Johansson relative to a claim for property damage.

Whereas, Members of the Judiciary and Legislation Committee have reviewed the records relating to this claim in the amount of \$413.08, relating to damage sustained on October 19, 2005 when City of Milwaukee police made forced entry into private property at 2756 North 88th Street. Based on this review, members of the Committee, despite the recommendation of the City Attorney, recommend that the claimant be reimbursed \$200.00 in payment of this claim; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper city officers be and they hereby are authorized and directed to issue a city check in the total sum of \$200.00 payable to Ingrid Johansson, 2756 North 88th Street, Milwaukee, WI 53222, to reimburse her for the damage; and, be it

Further Resolved, That the check is to be delivered upon presentation of a proper release, approved by the City Attorney; said amount to be charged to Account No. 636505, Fund - 0001, Organization - 1490, Program - 2631, Sub Class - S118. This resolution would release the City from any further liability arising from this incident.
