Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations. The City cost of these projects approved by this resolution is estimated to be \$309,000.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$309,000. Construction of these projects is anticipated to be during the 2006 construction season. Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

N. 87th St. - W. Chambers St. to W. Burleigh St. (ST211060109) File Number 040945: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$24,300; Nonassessable

Reconstruction Paving Fund -- \$40,000). The total cost to date for this project including the requested amount is \$74,300. This project is anticipated to be completed during the 2006 construction season.

W. Walnut St. (South Roadway) - N. 6th St. to N. 10th St. (ST211060158) File Number 050805: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$36,500; Nonassessable Reconstruction Paving Fund -- \$130,000). The total cost to date for this project including the requested amount is \$169,500. This project is anticipated to be completed during the 2006 construction season.

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects: N. 87th St. (ST211060109), W. Walnut St. (ST211060158), and W. Dakota St. (ST211060151) will be billed after January 1, 2008, and S. Crandon Pl. (ST211060173) and W. Midland Dr. (ST211060174) will be billed after January 1, 2009, but not before 12 months after the project contract has been completed; and, be it
