Construction of these projects is anticipated to be late spring or the summer of 2006, unless otherwise noted.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

E. Brady St. at N. Arlington Pl. (ST211060178) File Number 041218: Concrete crosswalks. (Nonassessable Reconstruction Paving Fund -- \$15,000). The total cost to date for this project

including the requested amount is \$70,000. Construction is complete and these funds are needed to close out the contract.

4th and 15th Aldermanic Districts

W. Galena St. - N. 15th St. to N. 18th St. (SM495050074) File Number 050718: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$400,000). The total cost to date for this project including the requested amount is \$435,000. This project is anticipated to be completed during the 2006 construction season.

N. 16th St. - 430 feet m/l south of W. Galena St. to W. Walnut St. (SM495050064) File Number 050718: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$144,000). The total cost to date for this project including the requested amount is \$169,000. This project is anticipated to be completed during the 2006 construction season.
