Resolution relative to application, acceptance, and funding of a 2006 and 2007 Vehicle Miles of Travel Monitoring Grant.

This resolution authorizes the Commissioner of Public Works to apply for, accept, and fund a 2006 and 2007 Vehicle Miles of Travel Monitoring Grant project from the Wisconsin Department of Transportation in the amount of \$74,901. The purpose of the project is to collect traffic count data to monitor traffic flow patterns in the City of Milwaukee.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Transportation (WISDOT) to provide expanded monitoring of roadway usage levels and travel characteristics in the City of Milwaukee; and

Whereas, The operation of this grant project from July 1, 2006 to June 30, 2007 would cost \$74,901 and would be provided by the grantor; now, therefore, be

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works and Comptroller are hereby authorized to make application to WISDOT through execution of the agreement attached and incorporated into this resolution; and, be it Further Resolved, That the Department of Public Works shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit Funds within the Project/Grant Parent of the 2006 and 2007 Special Revenue Grant and Aid Projects Fund the following amounts for the program/project titled 2006 and 2007 Vehicles Miles of Travel Monitoring Project:

2. Create a Special Revenue Fund - Grant and Aid Projects and the necessary Project/Grant Chartfield values at the Project, Segment, Phase, and/or Activity Levels; and to budget to the Project, Segment, Phase, and/or Activity Level the amount required under the grant agreement; and, be it

Further Resolved, That these funds are budgeted for the Department of Public Works, which is authorized to:

1. Expend from the amount budgeted for specific purposes as indicated in the grant budget and incur costs consistent with the award date; and

2. Expend from the 2006 and 2007 grant budget funds for training and out-of-town travel by departmental staff.
