Whereas, The Community Development Grants Administration is authorized to release a request-forproposal utilizing the 10% set-aside of 2006 CDBG Reprogramming funds for the City's Youth Council as approved in resolution number 040220; and

Whereas, The City's Youth Council will review the RFP's and submit recommendations based on the timeline as outlined in the attached schedule (see Attachment A); and

Further Resolved, That no representative of an applicant for reprogramming funds may contact, by any means, members of the Youth Council to advocate for such funding, except at a meeting of the Youth Council convened for that purpose, and that any such contact shall result in the disqualification of the applicant for reprogramming funds.
