This resolution authorizes the Health Department to accept and fund the Bader Lead Abatement Grant project from the Helen Bader Foundation in the amount of \$50,000. The purpose of the project is to conduct lead abatement in 27 housing units.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Helen Bader Foundation to conduct lead abatement in 27 housing units; and

Whereas, The operation of this grant project from 01/01/06 to 12/31/06 would cost \$50,000 to be provided by the grantor; now, therefore, be it
