200-33-26-e am

This ordinance increases the fee for a licensed dwelling facility license for a rooming house or a second class dwelling from \$166 to \$50 for each occupant of the facility at maximum permitted occupancy.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 200-33-26-d and e of the code is amended to read:

## 200-33. Fees.

### 26. LICENSED DWELLING FACILITIES.

d. Rooming house: [[~~\$166~~]] >>\$50 for each occupant at maximum permitted occupancy, as specified on the license<<.

e. Second Class Dwelling: [[~~\$166~~]] >>\$50 for each occupant at maximum permitted occupancy, as specified on the license<<.
