An ordinance relating to designated areas in which cruising is prohibited.

101-20.5-1-b-5 am

This ordinance prohibits cruising on the portion of West Capitol Drive from North 92nd Street west to the City limits. Cruising is already prohibited on Capitol Drive from North 92nd Street east to the Milwaukee River (City limits).

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-20.5-1-b-5 of the code is amended to read:

101-20.5. Cruising Prohibited.

1. DEFINITIONS.

b. "Designated area" means:

b-5. All of that portion of East and West Capitol Drive [[bounded by the Milwaukee River on the east and North 92nd Street on the west]] >>within the Milwaukee city limits<<. APPROVED AS TO FORM
