Whereas, Subsequently, the owner of each special privilege has removed all subject items from the public rightof-way in a manner that satisfies the Commissioners of Public Works and Department of Neighborhood Services; and

Whereas, Said owners notified the Department of Public Works that they no longer need the special privilege granted them; and

Whereas, In order to release property owners from the bonding, insurance and annual special privilege fee requirements placed on the property owner as part of the granting of a special privilege, the Common Council needs to pass a resolution rescinding special privileges which are no longer needed; now, therefore, be it
