This substitute resolution creates a study plan that identifies regulatory problems and states land use and development issues to be resolved for the area proposed for rezoning. Whereas, Section 295-1005 of the Milwaukee Code of Ordinances allows for the establishment of a study plan for an Interim Study Overlay District; and

Whereas, An Overlay District is an appropriate mechanism to ensure proper development of future construction for Bay View along South Wentworth Avenue; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that a study plan is established for this area and will apply to any future construction, a copy of which study plan is attached to this Common Council File as Exhibit A.
