Resolution permitting a minor modification to the Detailed Planned Development (DPD) known as Milwaukee Women's Pre-Release Facility located on the West Side of North 6th Street and South of West Keefe Avenue, in the 6th Aldermanic District. This resolution will allow for the addition of privacy slats in the existing chain link fence and the planting of larger arborvitae along portions of the North 7th Street frontage and portions of the southerly property line of the site. This modification will afford more privacy to persons using the outdoor recreation area. Whereas, Section 295-907-3(i) of the Milwaukee Code of Ordinances permits variation to planned developments after approval of the Common Council of the City of Milwaukee ("Common Council"); and

Whereas, The detailed plan for a planned development known as Milwaukee Women's Pre-Release Facility was approved by the Common Council on December 21, 2001, under File No. 011159; and

Whereas, The proposed modification to the fence and landscaping is consistent with the spirit and intent of the approved plan and will not adversely affect surrounding development and a copy of which is attached to this Common Council File as Exhibit A
