The City cost of the projects approved by this resolution is estimated to be \$1,828,000. The total estimated cost of these projects is \$1,946,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

E. Ivanhoe PI. - N. Summit Ave. to N. Lake Dr. (SM495050028) File Number 050136: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$69,000) File Number 050136 authorized \$10,000. The total estimated cost for this project including the requested amount is \$79,000. This project is anticipated to be completed during the 2006/2007 construction season.

N. Summit Ave. - E. Kenilworth PI. to E. North Ave. (SM495060017) File Number 051658: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$224,000) File Number 051658 authorized \$12,000. The total estimated cost for this project including the requested amount is \$236,000. This project is anticipated to be completed during the 2006/2007 construction season.

E. Wyoming Pl. - N. Summit Ave. to N. Lake Dr. (SM495060019) File Number 051658: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$34,000) File Number 051658 authorized \$4,000.
