THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$70,000 for a total estimated cost of these projects being \$2,625,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$70,000 with the total cost estimated to be \$2,625,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

2nd Aldermanic District

N. 50th St. - W. Hope Ave. to W. Congress St. (ST211060146): Paving the roadway with asphalt.

Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$3,000, additional engineering funds). File Number 041236 authorized \$10,000. The total estimated engineering cost including this request is \$13,000. The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2007 construction season.

2nd and 7th Aldermanic Districts

N. 51st Bl. - W. Keefe Ave. to W. Capitol Dr. (ST211070103): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$5,000, additional engineering funds). File Number 050224 authorized \$20,000. The total estimated engineering cost including this request is \$25,000. The total estimated cost for this project including the requested amount is \$380,000. N. Fratney St. - E. Burleigh St. to E. Auer Ave. (ST211070134): Replace curb. (Nonassessable Reconstruction Paving Fund -- \$5,000, additional engineering funds). File Number 051328 authorized \$5,000. The total estimated engineering cost including this request is \$10,000. The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2007 construction season.

N. 85th St. - W. Keefe Ave. to W. Vienna Ave. (ST211070108): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$3,000, additional engineering funds). File Number 050319 authorized \$10,000. The total estimated engineering cost including this request is \$13,000. The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2008 construction season.

The total estimated engineering cost including this request is \$45,000. The total estimated cost for this project including the requested amount is \$410,000. W. Nash St. - N. 56th St. to N. 60th St. (ST211060132): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$1,000, additional engineering funds). File Number 050933 authorized \$12,000. The total estimated engineering cost including this request is \$13,000. The total estimated cost for this project including the requested amount is \$141,000. This project is anticipated to be completed during the 2008 construction season.

8th Aldermanic District

S. 45th St. - W. Oklahoma Ave. to W. Cleveland Ave. (ST211060104): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$7,000, additional engineering funds). File Number 040588 authorized \$15,000. The total estimated engineering cost including this request is \$22,000. The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2007 construction season.

N. Burbank Ave. - W. Casper St. to W. Spokane St. (ST211060125): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$3,000, additional engineering funds). File Number 051223 authorized \$21,000. The total estimated engineering cost including this request is \$24,000. The total estimated cost for this project including the requested amount is \$220,000. This project is anticipated to be completed during the 2007 construction season.

10th Aldermanic District

N. 64th St. - W. Nash St. to a point north of W. Nash St. (ST211070102): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$ 3,000, additional engineering funds). File Number 050224 authorized \$5,000. The total estimated engineering cost including this request is \$8,000. The total estimated cost for this project including the requested amount is \$64,000. This project is anticipated to be completed during the 2008 construction season.

11th Aldermanic District

W. Dakota St. - S. 68th St. to S. 72nd St. (Portions in the City of West Allis) (ST211060112): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$10,000, additional engineering funds). File Number 060372 authorized \$20,000. The total estimated engineering cost including this request is \$30,000. The total estimated cost for this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2007 construction season.

W. Ohio Ave - S. 76th St. to S. 84th St. (ST211070107): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$7,000, additional engineering funds). File Number 050224 authorized \$25,000. The total estimated engineering cost including this request is \$32,000. The total estimated cost for this project including the requested amount is \$345,000. This project is anticipated to be completed during the 2007 construction season.

E. Conway St. - S. Logan Ave. to S. Kinnickinnic Ave. (ST21160142): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$6,000, additional engineering funds). File Number 051660 authorized \$28,600. The total estimated engineering cost including this request is \$34,600. The total estimated cost for this project including the requested amount is \$285,000. This project is anticipated to be completed during the 2008 construction season.

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
