Whereas, Clear Channel Outdoor, Inc. has offered to lease a portion of the Redevelopment Authority of the City of Milwaukee ("Authority") property at 708 West Garfield Avenue to relocate an existing billboard from 2233 North 7th Street to facilitate development of the Bronzeville project; and

Whereas, On December 14, 2006, the Authority held a Public Hearing on the proposed lease as required by Wisconsin Statutes; and
