Resolution relative to the acceptance and funding of the Analysis of Impediments award from Milwaukee County.

This resolution allows the City of Milwaukee - Community Development Grants Administration to accept the Analysis of Impediments award in the amount of \$24,900 from Milwaukee County. The funding represents Milwaukee County's share of the project.

Whereas, The Department of Housing and Urban Development requires entitlement communities receiving Community Development Block Grant funding to periodically prepare an Analysis of Impediments to Fair Housing Choice (AI); and

Whereas, The Milwaukee County has approved the award of \$24,900 to the City of Milwaukee - Community Development Grants Administration to coordinate a countywide AI report; and

Whereas, The operation of this award from December 23, 2013 through December 31, 2014 would cost \$24,900 which will be provided by Milwaukee County; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, the Community Development Grants Administration shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it
