Whereas, The City is planning to relay an existing 72-inch diameter in North Hubbard Street between East Lloyd Street and East Garfield Avenue; and

Whereas, MMSD owns an intercepting structure that the 72-inch diameter City sewer is connected to and is planning to reconstruct the intercepting structure; and

Whereas, MMSD is willing to reimburse the City for adding the reconstruction of the intercepting structure work to the City contract for relaying the existing 72-inch diameter sewer at their own expense as detailed in the Intergovernmental Cooperation Agreement, said agreement is hereto attached and made part of this resolution; and

Whereas, This agreement must be approved by a MMSD resolution expected to be voted on at the April 30, 2007 MMSD commission meeting; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works is hereby directed to execute an Intergovernmental Cooperation Agreement with MMSD to construct an intercepting
