THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$423,000 for a total estimated cost of these projects being \$4,603,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$423,000 with total cost estimated to be \$4,603,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described improvements according to city specifications:

3rd Aldermanic District

N. Bartlett Ave. - E. Lafayette Pl. to E. North Ave. (SM495070044): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000) The total estimated cost of this project including this request is \$309,000. This project is anticipated to be completed during the 2008 construction season.

N. Bartlett Ave. - E. Thomas Ave. to 167' +/- north of E. Thomas Ave. (SM495070047): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$11,000) The total estimated cost of this project

including this request is \$97,000. This project is anticipated to be completed during the 2008 construction season.

N. Cambridge Ave. - E. North Ave. to E. Boylston St. (SM495070050): Relaying and lining combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$13,000) The total estimated cost of this project including this request is \$150,000. This project is anticipated to be completed during the 2008 construction season.

N. Marshall St. - E. Juneau Ave. to E. Ogden Ave. (SM495070064): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000) The total estimated cost of this project including this request is \$117,000. This project is anticipated to be completed during the 2008 construction season.

N. Murray Ave. - E. Bellevue Pl. to 200' +/- N. of E. Park Pl. (SM495070058): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost of this project including this request is \$94,000. This project is anticipated to be completed during the 2008 construction season.

N. Newhall St. - E. Thomas Ave. to E. Bradford Ave. (SM459070054): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$21,000) The total estimated cost of this project including this request is \$256,000. This project is anticipated to be completed during the 2008 construction season.

N. Newhall St. - E. Thomas Ave. to E. North Ave. (SM495070053): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$12,000) The total estimated cost of this project including this request is \$185,000. This project is anticipated to be completed during the 2008 construction season.

N. Oakland Ave. - E. Woodstock Pl. to 130' +/- north of E. Woodstock Pl. (SM495070057): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$10,000) The total estimated cost of this project including this request is \$125,000. This project is anticipated to be completed during the 2008 construction season.

N. Prospect Ave. - 200' +/- south of E. Park Pl. to E. Park Pl. (SM495070063): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost of this project including this request is \$36,000. This project is anticipated to be completed during the 2008 construction season.

N. Summit Ave. - E. Kenilworth Pl. to E. Windsor Pl. (SM495070067): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$19,000) The total estimated cost of this project including this request is \$235,000. This project is anticipated to be completed during the 2008 construction season.

E. Thomas Ave. - 250' +/- west of N. Newhall St. to N. Newhall St. (SM495070046): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000) The total estimated cost of this project including this request is \$105,000. This project is anticipated to be completed during the 2008 construction season.

E. Thomas Ave. - N. Oakland Ave. to N. Bartlett Ave. (SM495070049): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$11,000) The total estimated cost of this project is \$90,000. This project is anticipated to be completed during the 2008 construction season.

E. Woodstock Pl. - N. Oakland Ave. to N. Farwell Ave. (SM495070056): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$18,000) The total estimated cost of this project including this request is \$199,000. This project is anticipated to be completed during the 2008 construction season.

E. Woodstock Pl. - N. Terrace Ave. to N. Prospect Ave. (SM495070051): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$29,000) The total estimated cost of this project including this request is \$532,000. This project is anticipated to be completed during the 2008 construction season.

(Nonassessable Sewer Maintenance Relay Fund -- \$11,000) The total estimated cost of this project including this request is \$42,000. N. Jefferson St. - E. Buffalo St. to E. St. Paul Ave. (SM495070061): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$11,000) The total estimated cost of this project including this request is \$57,000. This project is anticipated to be completed during the 2008 construction season.

N. Plankinton Ave. - W. Wisconsin Ave. to W. Wells St. (WT410071001): Water Main Alterations. (Nonassessable Water Fund -- \$15,000) The total estimated cost of this project including this request is \$165,000. This project is anticipated to be completed during the 2007 fall construction season.

N. Van Buren St. -- E. Buffalo St. to E. St. Paul Ave. (SM495070059): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost of this project including this request is \$35,000. This project is anticipated to be completed during the 2008 construction season.

6th Aldermanic District

N. Hubbard St. - E. Meinecke Ave. to E. North Ave. (SM495070026): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$14,000) The total estimated cost of this project including this request is \$177,000. This project is anticipated to be completed during the 2008 construction season.

W. Lincoln Ave. - S. 23rd St. to W. Forest Home Ave. (SM495070068): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost of this project including this request is \$65,000. This project is anticipated to be completed during the 2008 construction season.

N. 78th St. - W. Stevenson St. to W. Mt. Vernon Ave. (SM495070076): Sewer Maintenance Relay Nonassessable storm lining. The total estimated cost of this project including this request is \$107,000. This project is anticipated to be completed during the 2007 construction season.

W. Mt. Vernon Ave. - N. 78th St. to Honey Creek (SM495070077): Sewer Maintenance Relay Nonassessable storm lining. The total estimated cost of this project including this request is \$87,000. This project is anticipated to be completed during the 2007 construction season.
