Whereas, Section 7.03, Wis. Stats., holds that daily compensation shall be paid to each inspector, voting machine custodian, automatic tabulating equipment technician, member of a board of canvassers, messenger and tabulator who is employed in performing elections duties; and

Whereas, Many cities throughout the country have implemented adopt-a-site programs whereby persons affiliated with certain charitable organizations fully staff polling sites during each election and assign their compensation to the affiliated charitable organizations; and

Whereas, These programs increase civic participation, attract new poll workers and provide support

to charitable organizations; and

Whereas, It is in the City of Milwaukee's best interest for the Election Commission to implement an Adopt-a-Site program; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Election Commission is directed to implement an Adopt-a-Site program, whereby persons affiliated with certain charitable organizations fully staff polling sites during each election and assign their compensation to the affiliated charitable organizations; and, be it

Further Resolved, That for a charitable organization to qualify for the Adopt-a-Site program, it must be a charitable organization as defined in s. 11.01(2), Wis. Stats., and 26 USC s. 170(c)(2), or 26 USC s. 501(c)(3).
