Whereas, On June 7, 1989, The Brewery Works, Inc. granted the City of Milwaukee a sewer and water easement SE-2505/WE-677 located in parcel of land lying northeast of East Pleasant Street between North Commerce Street and a point 325 east of North Commerce Street; and

Whereas, The sewer and water main facilities that were planned to be constructed in this easement have never been constructed; and

Whereas, The present owner has requested the release of said easements; and

Whereas, The City has determined the sewer and water easements are no longer required for future sewer and water main purposes and no longer serves the interest of the City of Milwaukee and therefore can be released;
