Substitute resolution relative to application, acceptance and funding of the Plain Talk Initiative - United Way Grant from the United Way.

This resolution authorizes the Health Department to apply for, accept and fund the Plain Talk Initiative - United Way Grant from the United Way in the amount of \$50,000. The purpose of the project is to provide a community-based initiative aimed at helping parent develop the skills and tools they need to communicate effectively with their children about abstinence, healthy relationships, and sexuality.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the United Way to provide this community-based initiative; and

Whereas, The operation of this grant project from 10/01/07 to 12/28/08 would cost \$50,000 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the United Way is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2007 Special Revenue-Grant and Aid Projects Fund, the following amount for the project titled Plain Talk Initiative - United Way Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amounts required under the grant agreement; and, be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

- 1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Enter into subcontracts and leases as detailed in the grant budget; and
- 3. Expend from the 2007 grant budget funds for training and out-of-town travel by departmental staff.
