THE CHAIR

Substitute motion revoking the Class "B" Tavern license of Montal Hinton for "Montal's Lounge" at 2525 N. Holton St.

Whereas, Five citizens filed notarized complaints requesting the revocation of the Class "B" Tavern license of Montal Hinton for "Montal's Lounge" at 2525 N. Holton St. based upon shootings, loitering, noise, public urination, litter, blocking of the public street and sidewalk, and verbal abuse of the neighbors by bar patrons ; and

Whereas, The licensee was served with a copy of the complaints and the police report on January 14, 2008; and

Whereas, The Licenses Committee held an evidentiary hearing on January 22, 2008; and

Whereas, Based on testimony provided at this hearing by 2 of the original 5 complainants and other parties, the Committee voted to revoke the license of Montal Hinton for "Montal's Lounge" at 2525 N.

Holton St. by a vote of 3 ayes, one abstain and one excused; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Class "B" Tavern license of Montal Hinton for the premises at 2525 N. Holton St. ("Montal's Lounge") is revoked.
