Whereas, The Community Development Grants Administration (CDGA) received the attached letter from the Metcalfe Park Neighborhood Association regarding the transfer of their 2008 CDBG funding; and

Whereas, The Community Development Grants Administration plans to release a Request-for-Proposal (RFP) in the amount of \$44,000 for Neighborhood Strategic Planning Area (NSP 8) for the activity of Community Organizing /Crime Awareness Prevention/Neighborhood Strategic Planning; and

Whereas, The Community & Economic Development Committee authorizes the release of the RFP in the amount of \$44,000 of CDBG funding for NSP 8; now therefore, be it
