Whereas, Various area fire departments desire to enter into a mutual service agreement for the protection of life and property from fire and other disasters in their respective communities; and

Whereas, Section 66.0301(2), Wis. Stats., authorizes municipalities to contract with other municipalities for the receipt or furnishing of fire protection and emergency medical services; and

Whereas, Section 66.0301(2), Wis. Stats., authorizes fire departments to engage in mutual assistance within a requesting fire department's jurisdiction; and

Whereas, The details of the assistance to be provided by individual fire departments will be set forth in separate Memoranda of Understanding executed by 2 or more of the parties to this Agreement for Mutual Assistance, a copy of which is attached to this file; and

Whereas, The Common Council believes that the Agreement for Mutual Assistance for purposes of public safety and protection should be encouraged; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Fire Department is authorized to enter into an Agreement for Mutual Assistance, a copy of which is attached to this file, with participating area fire departments for the furnishing of fire protection and emergency medical services; and, be it

Further Resolved, That the proper City officials are directed to execute the Agreement for Mutual Assistance on behalf of the City.
