Whereas, Additional planning and review during the design phase have resulted in increased costs charged against the subject capital improvement project; and

Whereas, Additional funds are, therefore, necessary for the estimated Wisconsin Department of Transportation and City

of Milwaukee preliminary engineering costs for this project; now, therefore, be it.
