THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$317,000 for a total estimated cost of these projects being \$3,178,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$317,000 with the total cost estimated to be \$3,178,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st and 9th Aldermanic Districts

N. Hopkins St. - A point south of W. Florist Ave. to a point north of W. Douglas Ave. (ST211150142): Paving the roadway with asphalt. Rural cross section. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$570,000. This project is anticipated to be completed during the 2015 construction season.

# 5th Aldermanic District

N. 81st St. - W. Courtland Ave./W. Beckett Ave. to W. Hampton Ave. (ST211150132): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2015 construction season.

N. 83rd St. - W. Keefe Ave. to W. Capitol Dr. (ST211150133): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$30,000. The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2015 construction season.

W. Garfield Ave. - N. Dr. Martin Luther King Jr. Dr. to N. 4th St. (ST211150150): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$18,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2015 construction season.

# 7th Aldermanic District

N. 54th Blvd. - W. Keefe Ave. to W. Melvina St. (ST211150114): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$30,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2015 construction season.

# 8th Aldermanic District

W. Mitchell St. - S. 38th St. to a point east of Miller Park Way (Portions in the Village of West Milwaukee) (ST211150143): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$22,000). The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2015 construction season.

W. Waterford Ave. - A point east of S. 73rd St. to S. 75th St. (ST211150140): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$145,000. This project is anticipated to be completed during the 2015 construction season.

# 12th Aldermanic District

Alley between W. Arthur Ave., W. Harrison Ave., W. Windlake Ave., S. 18th St., and S. 19th St. (ST212150112): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2015 construction season.

Alley between W. Harrison Ave., W. Windlake Ave., and S. 20th St. (ST212150113): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2015 construction season.

- W. Van Beck Ave. S. 20th Pl. to S. 24th St. (ST211150145): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$22,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2015 construction season.
- S. 20th Pl. W. Van Beck Ave. to W. Howard Ave. (ST211150146): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2015 construction season.

This project is anticipated to be completed during the 2015 construction season.

Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$280,000. S. 24th St. - W. Van Beck Ave. to W. Howard Ave. (ST211150148): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$98,000. This project is anticipated to be completed during the 2015 construction season.

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
