Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$100,000 for a total estimated cost of these projects being \$980,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$100,000 with the total cost estimated to be \$980,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

5th Aldermanic District

W. Hope Ave. - N. 81st St. to N. 82nd St. (WT410150603): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2015 construction season.

N. 81st St. - W. Fiebrantz Ave. to W. Hope Ave. (WT410150602): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$145,000.

This project is anticipated to be completed during the 2015 construction season.

8th Aldermanic District

W. Greenfield Ave. - S. 35th St. to S. 37th St. (WT410150604): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2015 construction season.

11th Aldermanic District

S. 91st St. - W. Holt Ave. to 125 feet south of W. Verona Ct. (WT410150601): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2015 construction season.

12th and 14th Aldermanic Districts

W. Becher St. - S. 1st St. to S. 4th St. (WT410140703): Water main rehabilitation. (Nonassessable Water Fund Budget Line 5010 -- \$6,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost for this project including the requested amount is \$270,000. This project is anticipated to be completed during the 2014 construction season.

15th Aldermanic District

W. North Ave. - N. 30th St. to N. 31st St. (WT410140704): Water main rehabilitation. (Nonassessable Water Fund Budget Line 5010 -- \$6,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost for this project including the requested amount is \$240,000. This project is anticipated to be completed during the 2014 construction season.
