THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-15 of the Code relating to Yield signs is amended by striking the following:

"On West Thurston Avenue at North 65th Street"

Part 2. Section 101-15 of the Code relating to Yield signs is amended by adding the following:

On North 78th Street at West Townsend Avenue

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

"On West Thurston Avenue at North 67th Street"

"On North 65th Street at West Carmen Avenue"

"On North 67th Street at West Carmen Avenue"

Part 4. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On North Edgeworth Drive at North Highview Drive

On West Carmen Avenue and North 65th Street in all directions

On West Carmen Avenue and North 67th Street in all directions

On West Lawrence Avenue and North 88th Street in all directions

On West Thurston Avenue and North 65th Street in all directions

On West Thurston Avenue and North 67th Street in all directions
