This resolution authorizes the Health Department to accept and fund the 2014-15 Implementing Voluntary National Retail Food Regulatory Program Standards Grant from the Food and Drug Administration (FDA) in the amount of \$70,000. The purpose of the grant is to allow MHD to examine current policies and procedures in the Consumer Environmental Health Section and provide an opportunity to adopt best practices to improve the program.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Food and Drug Administration (FDA) for the 2014-15 Implementing Voluntary National Retail Food Regulatory
