SUBSTITUTE 1

THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$198,000 for a total estimated cost of these projects being \$3,187,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$198,000 with the total cost estimated to be \$3,187,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

N. Teutonia Ave. - W. Capitol Dr. to W. Ruby Ave. (SM495140065): Sanitary lining and storm relay. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$1,458,000. This project is anticipated to be completed during the 2015 construction season.

N. Teutonia Ave. - W. Capitol Dr. to W. Ruby Ave. (WT410150001): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$160,000. This project is anticipated to be completed during the 2015 construction season.

4th Aldermanic District

Highland Community School Bioswales - 1706 W. Highland Blvd. and on W. Juneau Ave. - N. 17th St. to N. 18th St. (SM493130110): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$15,000. This project is anticipated to be completed during the 2015 construction season.

5th Aldermanic District

W. Grantosa Dr. (Easement) - W. Grantosa Dr. to N. 84th St. (SM494140209): Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2014 construction season.

6th Aldermanic District

W. Garfield Ave. at N. 7th St. (ST211140182): Intersection modifications. (Nonassessable Reconstruction Paving Fund -- \$5,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2014 construction season.

8th Aldermanic District

W. Mitchell St. - S. 37th St. to Miller Parkway (SM495140068): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$149,000. This project is anticipated to be completed during the 2015 construction season.

10th Aldermanic District

S. Hawley Rd. - W. Main St. to railroad right-of-way (SM495140073): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$343,000. This project is anticipated to be completed during the 2015 construction season.

11th Aldermanic District

S. 29th St. - W. Dakota St. to W. Kinnickinnic River Pkwy. (WT410150702): Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2015 construction season.

S. 47th St. - W. Oklahoma Ave. to W. Forest Home Ave. (SM495140069): Sanitary lining and storm

relay. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$78,000. This project is anticipated to be completed during the 2015 construction season.

12th Aldermanic District

Pulaski Park Neighborhood Green Alleys - Alley bounded by S. 20th St., W. Harrison Ave., W. Windlake Ave., and W. Arthur Ave. (SM493130109): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2015 construction season.

13th Aldermanic District

W. Eden PI. - S. 8th St. to S. 11th St. (SM495140070): Sanitary lining and storm relay. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$104,000. This project is anticipated to be completed during the 2015 construction season.

S. 2nd St. - W. Edgerton Ave. to 250 feet m/l north of W. Vogel St. (SM495140072): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$49,000. This project is anticipated to be completed during the 2015 construction season.

S. 20th Pl. - W. Howard Ave. to W. Van Beck Ave. (SM495140067): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$32,000. This project is anticipated to be completed during the 2015 construction season.

14th Aldermanic District

S. Clement Ave. - E. Pryor Ave. to S. Kinnickinnic Ave. (SM495140071): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2015 construction season.

15th Aldermanic District

W. North Ave. - N. 30th St. to 85 feet m/l east of N. 31st St. (SM495140066): Combined sewer relay and lining, and combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$209,000. This project is anticipated to be completed during the 2015 construction season.

City Wide

Maintenance of Bioretention Facilities (SM493130111): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2014 construction season.

Milwaukee County

Maintenance of Milwaukee County's Menomonee River Parkway Lagoon (File No. 131124) - N. Menomonee River Pkwy. between W. Concordia Ave. and W. Auer Ave. (SM493130108): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2015 construction season.
