This resolution amends Common Council Files #131106, 131365 and 131721 relative to acceptance and funding of the 2014 Women, Infants and Children's Grant from the State of Wisconsin Division of Health Services. The purpose of the project is to prevent nutrition-related health problems and to improve the health status of low-income, at-risk pregnant or breast-feeding women, infants and children up to the age of five years.

Whereas, Common Council Resolution #131106, 131365 and 131721 authorized the Health Department to

accept and fund the 2014 Women, Infants and Children's Grant from the State of Wisconsin Division of Health and Family Services for the purpose of preventing nutrition-related health problems and to improve the health status of low-income, at-risk pregnant or breast-feeding women, infants and children up to the age of five years. This grant provided for a Grantor share total of \$1,610,016 and Program Income of \$200,000; and

Whereas, the total expenditures of this program has been reduced by \$13,919 to a total of \$1,596,097 of which provided by the grantor in addition to Program Income of \$200,000; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that application to the State of Wisconsin Division of Health Services is authorized and the Health Department shall accept such a grant without further Common Council approval unless the terms of the grant changes as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the Common Council directs that the 2014 Positions Ordinance C.C. File Number 130420 should be amended as follows:
