This zoning change was requested by St. Matthew CME Church and will permit 2965 and 2977-79 North 8th Street, zoned commercial, to be joined with property to the south, zoned residential, for construction of a church. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:
