This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$2,224,000. The total estimated cost of these projects is \$4,910,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Birch Ave. - N. Milwaukee River Pkwy. to N. 11th St. (WT410110638) File Number 140281:

Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$10,000, Additional Funds). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2014 construction season.

W. Custer Ave. - N. 27th St. to 300 feet west of N. 27th St. (WT410110647) File Number 140281: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$20,000, Additional Funds). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2014 construction season.

N. Milwaukee River Pkwy. - 900 feet south of W. Lawn Ave. to 730 feet south of W. Lawn Ave. (WT410110639) File Number 140281: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$24,000, Additional Funds). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2014 construction season.

N. 13th St. - 50 feet north of W. Birch Ct. to W. Silver Spring Dr. (WT410101031) File Number 131243: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$10,000, Additional Funds). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2014 construction season.

N. 28th St. - 400 feet north of W. Villard Ave. to 900 feet north of W. Villard Ave. (WT410110648) File Number 131243: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$15,000, Additional Funds). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2014 construction season.

N. 29th St. - 675 feet north of W. Villard Ave. to 900 feet north of W. Villard Ave. (WT410110649) File Number 131243: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$10,000). The total estimated cost for this project including the requested amount is \$65,000. This project is anticipated to be completed during the 2014 construction season.
