THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-15 of the Code relating to Yield signs is amended by striking the following:

"On North 49th Street at West Vine Street"

Part 2. Section 101-15 of the Code relating to Yield signs is amended by adding the following:

On North 74th Street at West Medford Avenue

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

"On North 80th Street at West Hadley Street"

Part 4. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On South 24th Street at West Warnimont Avenue

On North 26th Street at West Ruby Avenue

On North 38th Street at West Ruby Avenue

- On North 41st Street at West Custer Avenue
- On North 49th Street at West Vine Street
- On North 73rd Street at West Medford Avenue
- On West Chambers Street and North 85th Street in all directions
- On West Hadley Street and North 80th Street in all directions

Part 5. Section 101-18-1 of the Code relating to No Heavy Traffic is amended by adding the following:

On North 24th Street at West Capitol Drive northbound
