THE CHAIR

Resolution authorizing the execution of an Overhead Highway Bridge Easement between the City of Milwaukee and the Soo Line Railroad Company, doing business as Canadian Pacific, for the reconstruction of the West North Avenue Bridge over the railroad tracks between North 30<sup>th</sup> Street and North 31<sup>st</sup> Street.

This resolution will approve and authorize the execution of an Overhead Highway Bridge Easement with the Soo Line Railroad Company, doing business as Canadian Pacific, for the reconstruction of the West North Avenue Bridge over the railroad tracks.

Whereas, Negotiations have taken place between the Soo Line Railroad Company and the City of Milwaukee to finalize an Overhead Highway Bridge Easement regarding the construction of bridge overpass; and

Whereas, The easement is needed to accommodate concrete leveling pads, four retaining walls and bridge footings that comprise the support structure of the new bridge that will encroach into a portion of the Soo Line Railroad Company right-of-way; and

Whereas, The City of Milwaukee has forwarded the draft Overhead Bridge Easement document to the Soo Line Railroad Company for formal approval; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Overhead Highway Bridge Easement between the City of Milwaukee and the Soo Line Railroad Company, doing business as Canadian Pacific, for the reconstruction and

maintenance of the West North Avenue Bridge over the railroad tracks between North 30<sup>th</sup> Street and North 31<sup>st</sup> Street is hereby approved, a copy of which is attached to Common Council Resolution File Number 141084 and incorporated in this resolution by reference as though set forth therein in full; and, be it

Further Resolved, That the Commissioner of Public Works and Comptroller are hereby authorized and directed to execute said Overhead Highway Bridge Easement on the city's behalf; and, be it

Further Resolved, That minor changes to the Overhead Highway Bridge Easement which do not change its intent are hereby approved.
