Whereas, The plaintiff, Alfonso Morales, and another individual have filed a lawsuit against the City of Milwaukee, Monica Ray and Arthur Jones which resulted initially in a judgment of \$285,531.43; and

Whereas, Following an appeal, the plaintiff, Alfonso Morales, has agreed to settle this lawsuit in the amount of \$112,000.00; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to pay this lawsuit; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper City officials be and are hereby authorized and directed to issue a City check in the amount of \$112,000.00 payable to the order of Rettko Law Offices, S.C. Trust Account, in full and final settlement of all monetary damages sought in this lawsuit, including reasonable attorney's fees and costs, on receipt of a Release of
