THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,314,000 for a total estimated cost of these projects being \$5,474,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,314,000. The total estimated cost of these projects is \$5,474,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

N. Teutonia Ave. - W. Capitol Dr. to W. Ruby Ave. (SM495140065) File Number 140705: Sanitary lining and storm relay. (Nonassessable Sewer Maintenance Relay Fund -- \$1,735,000. The total estimated cost for this project including the requested amount is \$1,750,000. This project is anticipated to be completed during the 2015 construction season.

2nd Aldermanic District

N. 76th St. - W. Carmen Ave. to W. Florist Ave. (SM495130031) File Number 130146: Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$91,000). The total estimated cost for this project including the requested amount is \$103,000. This project is anticipated to be completed during the 2015 construction season.

8th Aldermanic District

W. National Ave. - S. 20th St. to S. 23rd St. (SM495130102) File Number 131076: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$475,000). The total estimated cost for this project including the requested amount is \$490,000. This project is anticipated to be completed during the 2015 construction season.

W. Orchard St. - S. 21st St. to S. 23rd St. (SM495130083) File Number 130688: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$123,000). The total estimated cost for this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2015 construction season.

8th and 12th Aldermanic Districts

W. Pierce St. - S. 20th St. to W. Reynolds PI. (SM495130096) File Number 131076: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$190,000). The total estimated cost for this project including the requested amount is \$205,000. This project is anticipated to be completed during the 2015 construction season.

S. 20th St. - W. Pierce St. to W. National Ave. (SM495130101) File Number 131076: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$375,000). The total estimated cost for this project including the requested amount is \$390,000. This project is anticipated to be completed during the 2015 construction season.

10th Aldermanic District

N. 60th St. - W. Lloyd St. to W. Wright St. (SM495140089) File Number 141120: Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$720,000). The total estimated cost for this project including the requested amount is \$740,000. This project is anticipated to be completed during the 2015 construction season.

10th and 15th Aldermanic Districts

W. North Ave. - W. Lisbon Ave. to N. 60th St. (SM495140082) File Number 140818: Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$466,000). The total estimated cost for this project including the requested amount is \$486,000. This project is anticipated to be completed during the 2015 construction season.

13th Aldermanic District

Layton Avenue Bioswales I-794 to S. Howell Ave. (Portions in the City of St. Francis) (SM499140109)

File Number 141250: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$114,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2015 construction season.

15th Aldermanic District

W. North Ave. - N. 30th St. to 85 feet m/l east of N. 31st St. (SM495140066) File Number 140705: Relaying combined sewer and combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$235,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2015 construction season.

Crackfilling of various streets by contract (ST211150185) File Number 141250: (Nonassessable Reconstruction Paving Fund -- \$295,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2015 construction season.

Seal coating of various streets by contract (ST211150186) File Number 141250: (Nonassessable Reconstruction Paving Fund -- \$345,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2015 construction season.

2015 Sewer Structures Inspection Project. (SM495140095) File Number 141250: (Nonassessable Sewer Maintenance Relay Fund -- \$45,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2015 construction season.

2015 Sanitary Manhole Inspection Project - City Wide (SM494140210) File Number 141250: (Infiltration/Inflow Reduction Fund -- \$105,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2015 construction season.
