Whereas, The City of Milwaukee requested an easement needed for sewer facilities located in the area south of West Meinecke Avenue and east of North 25<sup>th</sup> Street; and

Whereas, The easement area is in lands owned by St. Ann Center Properties, Inc; and

Whereas, The land-owner is willing to grant Sewer Easement SE-2849 to the City giving the City permission to enter the property to construct, operate, maintain, inspect, repair, enlarge, reconstruct, replace, and relocate, as City deems necessary, the combined main sewers and related facilities within the easement area on terms and conditions negotiated by the City's Department of Public Works, as reflected in the easement documents that have been made part of this file; now, therefore, be it
