A substitute ordinance relating to the membership of the city youth council.

320-45-3 am

320-45-4-e cr

Under this ordinance, children of elected city officials shall not be nominated to serve on the city youth council. In addition, members of the youth shall serve no more than 2 one year terms, either consecutively or non-consecutively.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 320-45-3 of the code is amended to read:

320-45. Youth Council.

3. SELECTION. The city clerk's office shall be responsible for recruitment of individuals to serve on the youth council. Nominations shall be submitted annually no later than October 1 to the common council for confirmation. No person shall be nominated who is >> a child, step-child, foster child or adopted child of an elected city official or << scheduled to graduate before the end of the term for which he or she is being nominated.

Part 2. Section 320-45-4-e of the code is created to read:
